1 - All sheep on the grounds are held at the consignor's risk until sold. At this time, the purchaser assumes the risk. The Ram Sale Committee assumes no responsibility whatsoever for the rams and ewes on the sale grounds prior to or after the sale. The Committee assumes no liability whatsoever for damage due to fire, flood, lockouts, accidents, war, or any other cause.

2 - The Ram Sale Committee will make every effort to conduct the sale in an honorable manner, allowing no false practices or false bidding. The Committee attempts to protect both buyer and seller in every reasonable way, but under no circumstances does the Ram Sale Committee assume any liability.

3 - The Ram Sale Committee disclaims liability for any injuries or damage to any person or property resulting from any cause whatsoever occurring on or about the grounds or premises whereon said Ram Sale is being held.

Minimum Weights

There are no minimum weight requirements, but animals may be sifted if the lay inspection committee feels they do not exhibit satisfactory size for the respective age, breed, or sex.
